ITEMS OF BUSINESS

- 1. Reading and approval of the Minutes from Saturday, February 2, 2014. "Robert" needs to be corrected to "Roberta". Elsa J. made a motion to approve the minutes. Laurel J. seconded. Motion carried.
 - 1, 4, 5, 6, 9 were pulled from the consent agenda. Annette B. made a motion to accept the consent agenda, Elsa J. seconded. Motion carried.

CONSENT AGENDA:

- Convention/Seminar (Jorgensen, Dexter, Nielsen, Pavlovich) Cheryl A. said the fall convention is planned. We have a good lineup in Ann Arbor. We need to make reservations for next year. Many other states are going to only one convention a year. Texas has theirs the weekend of NCRA testing. Nancy Varallo, President of NCRA, had indicated to Cheryl A. to not focus on that because NCRA will start to do their testing on-line. Since the board of directors can decide when to have the seminars, there was discussion about that issue. Cheryl A. will research hotels in Lansing for the last weekend in March.
- 2. Membership (Jacoby, Kandt, Smith, Blough, Pavlovich) Cheryl A. discussed the 20 people that have not renewed or cancelled. Proof of enrollment for student members was discussed.
- 3. Public Relations (Blough, Flick, Kandt, Smith) Laurel J. asked about career day at Linden schools on May 2nd. No response for anyone to do it. Laurel is willing to help but has never done one before. Sheri Pavlovich will help Laurel. Mindy D. is working on the Veteran's History project at her court, November 7, 2014. There will be 10 to 15 vets so we will need five court reporters to volunteer.
- 4. Freelance/Official (Kandt, Houghton, Smith, Pavlovich) Mindy D. discussed TRAIN. She would like to continue on with workshops and would like to work with reporters to

- get more dates on the calendar in August, October, and November. She would like the board to focus on half-day trainings CART, TRAIN, etc.
- 5. Students/Testing/Education (Kandt, Blough, Nielson, Pavlovich) Shari P. would like to get the word out to other firm owners about supporting students besides Hanson. MAPCR hasn't put any money in for scholarships for four years. Shari P. indicated Sharon K. would like to see the scholarships happening. Mindy D. indicated we will be giving a scholarship at the Fall convention and that we could also put it in the MAPCR Minute. Shari P. indicated Sharon K. gets many calls about the program, but if there is no financial aid, the students don't come. Shari P. asked if we can set aside a percentage of our fundraising for the students. She would also like to ask the software companies for contributions. We can put a donation button on the MAPCR website. Shari P. indicated students aren't coming to this seminar because there wasn't anything for them to do. They suggested brief clinics, mentor session. We need a student component every time. The board asked if Sharon K. could come up with things to do with the students. Shari P. is now in charge of student session planning.

There was an observation about Career Fairs and that people don't know what reporters do. We need to make sure they know all the career possibilities. There was discussion about a student member on the board and that we are still trying to figure out how to do it. The nomination committee will need to nominate someone. A student liaison will be added. Student corner/section on the MAPCR Minutes was suggested. Anyone can send suggestions to Mindy about the Minute to add things in.
